General

- As from 01/09/2024, in the context of the implementation of the PI1366 - Redesign L Gas Market - EDP BSYS, there will be no more new data available anymore related to the L-gas.

Release Notes: Implementation Information 1.5

General

- As from 31/01/2024, in the context of the implementation of the SSO, new technical contact with 'API User' role should be setup and used to run automatic downloads.
- The authentication is now using client ID and client server via the OAuth2 protocol. A new URL is set for the authentication endpoint :

- The endpoint URLs of all downloads is changed. Base URL of the endpoints to download reported is now : <https://apigateway.portalextranet.bsys.flbe.fluxys.com/>

NB : User created in the legacy User Administration system before 31/01/2024 will still be active and eligible for authenticating and running the automatic downloads. A transition phase is foreseen to migrate to the new SSO users created in the Fluxys Group CRM Platform.

Transmission

General

- 'Settlement Price' and 'Grid User Account Position' reports are extended to included information related to the new settlement prices (EBSP, *Excess Balancing Settlement Price*, and SBSP, *Shortfall Balancing Settlement Price*) and the settlement classification.

Changes

- New data in Settlement Price report to include the additional settlement prices for causers and helpers:
 - New optional attributes in the *SettlementPriceType* element available in the downloadable xml as described in the **SettlementPrice.xsd**:
 - E BSP for minor causer in *ExcessMinorCauserPrice*
 - E BSP for main causer in *ExcessMainCauserPrice*
 - E BSP for helper in *ExcessHelperPrice*
 - S BSP for minor causer in *ShortfallMinorCauserPrice*
 - S BSP for main causer in *ShortfallMainCauserPrice*
 - S BSP for helper in *ShortfallHelperPrice*
 - New columns are added in the downloadable csv (E BSP in *Excess* columns, S BSP in *Shortfall* columns) :
 - *GasDayZoneSettlementExcessMinorCauserPrice*
 - *GasDayZoneSettlementExcessMinorCauserPriceUnit*

 - New optional attributes in *Position* element in the downloadable xml as described in the **GridUserAccountPosition.xsd** :
 - *SettlementClassification*
 - Enumeration *SettlementClassificationType* listing the possible values of the SettlementClassification :
 - *MainCauser*
 - *MinorCauser*
 - *Helper*
 - *Neutral*

 - "WA"
 - "TA"
 - "BA"
